Clergy Report:

- 1. Pastor Nick mentioned the email he sent out regarding the finances. There is a list of payments to be made. Preschool did give us a back payment of \$7300.00 so we will be able to pay those outstanding bills. Preschool pays us about \$2600 to \$2800 a month.

New Business:

- b. Jason does not feel we have the funds this year but definitely should look at allocating in the future. Commit some of this to our budget as a benevolence.
 - b. Bring it to the staff that council is looking at committing to continuing education in the future.
 - c. Darrin will pitch it to the Personnel team to put out the classifications for continuing education allowance with stipulations for reimbursement.

- 3. Lawn Mower/Ryan: Dave Lundstrom would like to buy the mulcher. The \$50 that he is paying for it does not have to be approved by council.
- 4. Seraphim: There have been issues from people not using it or having trouble using it. One of Bev's goals is to do regular training sessions on this. We can pass this on to anyone that asks. Pastor Nick will share information to all unless they opt out of sharing their information.
