Approval of Agenda-Scott made a motion to approve the agenda. Jason 2<sup>nd</sup>. Motion approved Personnel Team Update:

- 1. Sometimes the personnel team is overwhelmed by issues from staff members.
- 2. Each staff member on their own is dedicated. Personnel team would like to build more team work. Trust issues with the staff and personnel team. Pastor Nick has a very large responsibility to keep the staff organized.
- 3. Every staff member should have an annual review. Cost of living raise would follow. This is not happening now. Would like to set this in place. A lot of freedom and little accountability of staff members.
- 4. Finance office is a big concern. Several credit cards for Holy Cross. What system is in place to monitor it? Scott said there is one credit card with 5 people having one. There is a limit for each person per month. (\$10,000 total limit on the credit card).
- 5. Duane does a compilation each month. \$250 or more needs to be approved. Member of congregation brought a concern of abuse in regard to Holy Cross credit cards. Pastor Nick said this was approved ahead of time.

Jason suggests that the reviews be spread out over the year. Suggested by Pastor Nick to offer Mental health care for staff members. (Maybe LSS). Jason would be willing to put a plan together along with Pastor and Personnel team for the annual reviews.

Treas. Report: Jason made a motion to approve the treasurer's report 2<sup>nd</sup>: Ryan Motion approved

- Added about \$8,000 to LOC so far, this summer
  A bit better than previous couple summers
- Payables are still current
- Preschool audit targeted for early September
- Interest only payments on the mortgage have ended
